## **W2 Professorship for Health and Risk Communication in General Practice and Family Medicine (Option on W2 after 5 years)**

is to be filled at the earliest possible date. The newly established professorship is initially limited to five years, a tenure-track procedure is planned to remove the time limit.

The professorship will represent the field of health and risk communication in general practice and family medicine in research and teaching. The position is based at the Institute of General Practice and Family Medicine (Director: Univ.-Prof. Dr. B. Weltermann, MPH(USA)). The institute is active in research, undergraduate and postgraduate medical training as well as continuous medical education." The institute includes the Bonn-Siegen-Eifel network of teaching and research practices with about 160 GP practices. The newly established W2 professorship is intended to strengthen the institute through the structured expansion of research in the field of health and risk communication. The tasks include the establishment and management of a research laboratory for research into health and risk communication of actors in the outpatient sector.

The applicant should be qualified and have proven scientific expertise in the field of health and/or risk communication. Extensive experience in communication and interdisciplinary research is essential, including methodological competence in the field of qualitative research with proven expertise in experimental research. In addition to international publications, this also includes proof of successful acquisition of third-party funds.

The prerequisites for employment are a completed university degree in communication sciences, psychology, sociology, health communication, risk communication or related subjects as well as a habilitation or equivalent scientific achievements pursuant to Section 36 Higher Education Act NRW (Hochschulgesetz - HG NRW).
